Neal Rud made a motion to approve the transfer of funds from County General to County Agent in the amount of \$50,000. Dave Gehrtz seconded the motion, and the motion carried.

OLD BUSINESS:

Paul Lies, Sheriff, gave an update. He has ordered a Ford Interceptor to replace one of the Dodge Chargers, deputies have been attending needed training, and he discussed the meeting with the Spirit Lake Tribe and the training required to police the reservation.

Neal Rud made a motion to select Interstate Engineering, Inc. to perform the preliminary and design engineering services for the Munster bridge project BRP-1400(050) PCN 23552. Dave Gehrtz seconded the motion, and the motion carried.

Dave Gehrtz made a motion to sign the Resolution to award Border States Paving, Inc. the contract for the HMA overlay and chip seal on the Lake Washington road, Project SC-CVD-1427(059). Neal Rud seconded the motion, and the motion carried.

Neal Rud made a motion to sign the Funding Agreement for Clerk of District Court Services with the ND Supreme Court. Dave Gehrtz seconded the motion, and the motion carried.

Todd Weber, Road Superintendent, gave an update. The Challenger tractor will be purchased from Agco Finance once the lease expires. Road rates charged to townships for maintaining and snowplowing were discussed. The rate is \$65 per hour for maintaining and \$70 per hour for snowplowing. Neal Rud made a motion to change the rate to \$70 per hour for both, and it was seconded by Dave Gehrtz. The motion carried.

Kris and Doug Skadberg attended the meeting to discuss the culverts on County Road 16. Ashley Lies, States Attorney, was also present for this discussion. Ashley stated that the Stream Crossing Determination is final as the County had 30 days to appeal it and we can no longer deny the terms of their study. She proposed that Interstate Engineering, Inc. either conduct its own analysis or work with Apex Engineering Group to make changes to their analysis. Ashley will forward information to Interstate Engineering, Inc. and request them to be present at the next meeting on June 7th.

NEW BUSINESS:

Dave Gehrtz made a motion to approve the Local Raffle Permit for Circle Trail Riders. Neal Rud seconded the motion, and the motion carried.

Neal Rud made a motion to approve the Fairgrounds Lease Agreement with Roger Duda, and it was seconded by Dave Gehrtz. The motion carried.

Dave Gehrtz made a motion to approve \$2,000 to support the Devils Lake Small Business Development Center. Neal Rud seconded the motion, and the motion carried.

Dave Gehrtz made a motion to raise election board pay to \$20 per hour for the inspector and \$18 per hour for judges and clerks. Neal Rud seconded the motion, and the motion carried.

2023 salaries and the cost of living were reviewed. Dave Gehrtz made a motion to increase county employees to the next step on the pay plan plus a 7.5% cost-of-living raise. Neal Rud seconded the motion, and the motion carried.

Glenda Collier, Chairperson, adjourned the meeting at 10:50 A.M.
